# CITY OF JEFFERSON RESOLUTION NO. 124

**WHEREAS**, the City of Jefferson, Wisconsin (hereinafter the City) entered into a Developer's Agreement on October 1, 2019 with International Investment Group Corporation; and

WHEREAS, a true and accurate copy of the Developer's Agreement (hereinafter the Agreement) is attached hereto as Exhibit "A" and incorporated herein; and

**WHEREAS**, the City has been informed that the motel that was the subject of the Agreement is to be sold to Best 4, LLC d/b/a BW Plus Jefferson Hotel, Brian Park – Owner; and

WHEREAS, the City is in agreement with this transaction.

NOW THEREFORE BE IT RESOLVED by the Common Council of the City:

- 1) That the terms and conditions set forth in the Agreement be assigned to Best 4, LLC d/b/a BW Plus Jefferson Hotel Brian Park as Owner (hereinafter the Buyer).
- 2) That the assignment is done with the understanding that the Buyer will be required to fulfill all obligations set forth in the Agreement.
- 3) That the next payment to be made by the City under the terms of the Agreement will be made to the Buyer no later than October 1, 2025 (there will be no proration) and thereafter until the City's obligation has been fulfilled.
- 4) That the parties hereto shall sign a formal agreement incorporating the terms set forth in this Resolution.

# **RESOLUTION FURTHER AMENDING THE DEVELOPER'S AGREEMENT WITH KUEHN ENTERPRISES, LLC**

#### CITY OF JEFFERSON RESOLUTION NO. 125

WHEREAS, the City of Jefferson, Wisconsin (hereinafter the City) has previously entered into a Developer's Agreement on November 13, 2012 (the agreement) with Kuehn Enterprises, LLC (the Owner/Developer); and

WHEREAS, the agreement was amended on February 4, 2025; and

WHEREAS, the parties hereto withs to further amend the agreement; and

WHEREAS, the most recent amendment is in the best interest of the City;

**NOW THEREFORE BE IT RESOLVED** by the Common Council of the City:

- 1) That the aforementioned amendment (attached hereto on Exhibit A) is found to be in the best interest of the City.
- 2) That the City Staff is authorized to execute any necessary documents and take such other steps to fulfill the intent of the amendment to the agreement.

# **<u>RESOLUTION AUTHORIZING EMERGENCY REPAIRS AT THE JEFFERSON FIRE STATION</u> (To be introduced by Ald. Neils.)**

# CITY OF JEFFERSON RESOLUTION NO. 126

**WHEREAS,** the Jefferson Fire Station sustained damage to the west side of the structure during a period of high winds in 2024, including the loss of vinyl siding and damage to the firring strips which hold said vinyl siding in place; and

**WHEREAS,** the repair project was originally funded with a \$20,000 reservation of fund balance in the 2023 audit of City operations. The project was delayed by lack of contractor interest in completing the repairs; and

**WHEREAS**, the project was re-bid with two bids received and a number of contractors declining to submit bids. Said bids ranged from \$22,516 to \$42,000 with the low bid submitted by Schloesser Construction, Inc., of Fort Atkinson, Wisconsin; and

**NOW, THEREFORE BE IT RESOLVED**, by the City Council of the City of Jefferson, Wisconsin that it herein approves and authorizes a contract with Schloesser Construction, Inc., in an amount not to exceed \$22,516 to complete the required repairs to the Jefferson Fire Station. Said contract is to be funded with a new reservation of fund balance in the 2024 audit of City operations.

Ald. Neils, seconded by Ald. Schroeder moved to approve Resolution No. 126. On call of the roll, Motion carried unanimously.
